## **RESOLUTION ADOPTED BY THE GENERAL ASSEMBLY**

[on the report of the Special Political and Decolonization Committee (Fourth Committee) (A/51/592)]

51/132. <u>Applicability of the Geneva Convention relative to the</u> <u>Protection of Civilian Persons in Time of War, of 12 August</u> <u>1949, to the occupied Palestinian territory, including</u> <u>Jerusalem, and the other occupied Arab territories</u>

The General Assembly,

Recalling its relevant resolutions,

Bearing in mind the relevant resolutions of the Security Council,

<u>Having considered</u> the reports of the Special Committee to Investigate Israeli Practices Affecting the Human Rights of the Palestinian People and Other Arabs of the Occupied Territories and the relevant reports of the Secretary-General,2/

Considering that the promotion of respect for the obligations arising from the Charter of the United Nations and other instruments and rules of international law is among the basic purposes and principles of the United Nations,

Stressing that Israel, the occupying Power, should comply strictly with its obligations under international law,

1. <u>Reaffirms</u> that the Geneva Convention relative to the Protection of Civilian Persons in Time of War, of 12 August 1949,<u>3</u>/ is applicable to the occupied Palestinian territory, including Jerusalem, and other Arab territories occupied by Israel since 1967;

2. <u>Demands</u> that Israel accept the <u>de jure</u> applicability of the Convention in the occupied Palestinian territory, including Jerusalem, and other Arab territories occupied by Israel since 1967, and that it comply scrupulously with the provisions of the Convention;

3. <u>Calls upon</u> all States parties to the Convention, in accordance with article 1 common to the four Geneva Conventions, <u>4</u>/ to exert all efforts in order to ensure respect for its provisions by Israel, the occupying Power, in the occupied Palestinian territory, including Jerusalem, and other Arab territories occupied by Israel since 1967;

4. <u>Requests</u> the Secretary-General to report to the General Assembly at its fifty-second session on the implementation of the present resolution.
