COMMISSION ON HUMAN RIGHTS Fifty-second session Item 4 of the provisional agenda

QUESTION OF THE VIOLATION OF HUMAN RIGHTS IN THE OCCUPIED ARAB TERRITORIES, INCLUDING PALESTINE

Note by the Secretary-General

- 1. In paragraph 6 of its resolution 1995/1, the Commission on Human Rights requested the Secretary-General to provide it with all United Nations reports issued between sessions of the Commission that deal with the conditions in which the citizens of the Palestinian and other occupied Arab territories are living under the Israeli occupation.
