# Protection of Civilians Weekly Report

23 - 29 April 2008

### Of note this week


#### Gaza Strip:

- The IDF killed nine Palestinians, including five children aged 1, 3, 4, 6, and 15 years, and injured 27 others. Four children, their mother and a Palestinian man (all unarmed civilians) were killed and 12 others were injured when an IAF helicopter fired two missiles that hit a Palestinian house during an IDF ground operation northwest of Beit Hanun.
- The IDF demolished six houses and uprooted 200 dunums of olive trees during its incursion east of Deir El Balah.
- The lack of sufficient fuel supplies continues to undermine all aspects of daily life in Gaza, including the use of wooden ovens, flooding of some sewage facilities, the closure of bakeries, and paralysis of the public transportation system.
- Following fuel shortage, UNRWA resumed its food distribution on 29 April and extended its hours of operation in an effort to reach those beneficiaries affected by the cessation of services since 25 April.
- Five demonstrations took place to protest against the blockade imposed on the Gaza Strip, including by school students, farmers and the Islamic Bloc of Agricultural Engineers and Agricultural Associations.
- A total of 42 rockets and 31 mortars were fired at Israel—a 35% decrease compared to last week. In addition, 71 mortars were fired at IDF soldiers inside the Gaza Strip.

#### West Bank:

- Two Israeli men who worked in Nitzani Oz industrial area west of Tulkarm were shot and killed by Palestinian militants.
- The general closure on the West Bank that began on 18 April continued until midnight on 27 April. The IDF denied all Palestinian permit holders access to East Jerusalem and Israel, except for emergency cases and employees at international organizations.
- Israeli settlers carried out several attacks against Palestinians, including (among others): throwing stones at Palestinian shepherds from Tuba (Hebron); attacking a Palestinian shepherd from Burqa, killing two of his sheep and stealing another two (Nablus); opening fire at and injuring a Palestinian man in Yasuf (Salfit); and physically assaulting a 40-year-old woman in the H2 area of Hebron City (Hebron).
- The IDF distributed seven demolition orders against six Palestinian houses and a water cistern and three stop-building orders against two houses and an animal pen (Nablus).
- Since 28 April, the IDF has opened the two metal gates at both sides of the 'Asira ash Shamaliya checkpoint and allowed free access between Nablus City and the northern villages between 0600 and 2200 hours.
- The Israeli Police and IDF denied thousands of Christian worshipers access to the Old City of Jerusalem and the Holy Sepulchre Church to celebrate Christian Holy Fire day.

## 1. Physical Protection – conflict related casualties

#### Gaza Strip:

- 24 April: A 51-year-old Palestinian (Hamas militant) was killed and three others were injured when an IAF helicopter fired a missile targeting a group of Hamas militants northeast of Beit Hanun (North Gaza).
- 24 April: Two Palestinian militants (Islamic Jihad members) and two unarmed civilians were injured when an IAF helicopter fired a missile targeting a group of Islamic Jihad militants east of Abassan area east of Khan Younis (Khan Younis).
- **26 April:** A 15-year-old Palestinian girl was killed and three others (unarmed civilians) were injured by live ammunition fired by the IDF during a ground operation two kilometres into north of Beit Lahiya. One of the injured Palestinians was the girl's father and he was later arrested by the IDF (North Gaza).
- 28 April: Four Palestinian children (aged 1, 3, 4 and 6 years), their 40-year-old mother and a 40-year-old man (unarmed civilians) were killed and 12 others were injured when an IAF helicopter fired two missiles that hit a Palestinian house northwest of Beit Hanun. The incident was part of an ongoing IDF ground operation northwest of Beit Hanun. According to Israeli media reports, one IDF soldier was wounded by Palestinian militants' fire (North Gaza).
- 28 April: A 20-year-old Palestinian man was killed and five others were injured by IDF tank shells due to IDF shelling in the course of an IDF ground operation northwest of Beit Hanun. At 2130 hours the IDF pulled back to the former industrial zone and the former Nissanit settlement (North Gaza).

#### Other incidents (not involving casualties):

- 27 April: IDF patrol boats opened fire at Palestinian fishing boats at sea west of Deir El Balah, forcing the boats to return to shore. No injuries were reported (Central Gaza).
- 29 April: IDF soldiers stationed at the former Nisanit settlement fired warning shots towards a Palestinian electricity technician attempting to repair the transformer northwest of Beit Hanun. No injuries were reported (North Gaza).

#### West Bank:

- 23 April: A 30-year-old Palestinian man from Hajja village was physically assaulted by the IDF while it was patrolling the village (Qalqiliya).
- 23 April: A 22-year-old Palestinian male from Qatanna village was injured by the IDF with live ammunition to the hips and legs following a verbal dispute between him and several other young men on the one hand and the IDF on the other hand when the IDF prevented them from walking close to the Barrier near the village (Jerusalem).
- **25 April**: Two Israeli men (aged 50 and 53 years) who worked in Nitzani Oz industrial area west of Tulkarm were shot and killed by Palestinian militants (Tulkarm).
- 25 April: A 23-year-old Palestinian man was injured in Yasuf by live ammunition when a
  group of Israeli settlers from Tappuah settlement entered the village and opened fire at
  Palestinians (Salfit).
- 25 April: Two Palestinian males from Shabtin village were injured by rubber-coated metal bullets fired by the IDF while participating in a demonstration with other Shabtin residents against the confiscation of village land by an Israeli settler who uses it to expand his stone-cutting business (Ramallah).
- 26 April: A Palestinian man was injured near Az Zawiya village by live ammunition when
  the IDF opened fire at him while he was trying to cross into Israel to reach his work
  (Salfit).
- 26 April: A 22-year-old Palestinian man was physically assaulted and injured by the IDF at Reikhan/Barta'a checkpoint (Jenin).
- 28 April: A 25-year-old Palestinian man from Jayyus village was physically assaulted and injured in 'Azzun village by the IDF since he entered the village while it was under curfew (Qalqiliya).
- 28 April: A 40-year-old Palestinian woman from the H2 area of Hebron City was physically assaulted by a group of Israeli settlers from the settlement of Kiryat Arba while she was walking towards her house (Hebron).

#### Other incidents (not involving casualties/damage):

- 23 April: Israeli settlers entered the evacuated settlement of Sanur and threw stones at Palestinian vehicles traveling on Road 60. No damage was reported (Jenin).
- 24 April: Israeli settlers physically attacked Palestinians, Israeli, and international
  activists northwest of Ramallah near 'Ein Qinya village who were calling for the

evacuation of an Israeli outpost established on the site of an evacuated IDF military installation. The IDF arrived and fired rubber-coated metal bullets at the demonstrators. No injuries were reported but three Palestinian protesters were arrested (Ramallah).

- **24 April:** Palestinians threw stones at an Israeli ambulance travelling near Damascus Gate. No injuries or damages were reported (Jerusalem).
- 25 April: Israeli settlers from settlements in the H2 area of Hebron City clashed with 120
  Palestinian, Israeli and international activists protesting the settler movement in the City.
  After the clashes, the IDF detained 60 Israeli activists and released them later (Hebron).
- 25 April: Dozens of cases of asphyxia were reported after the IDF used tear gas to disrupt the weekly demonstration held by Palestinians, Israeli, and international activists protesting Barrier construction in Bil'in (Ramallah).
- **25 April:** Several cases of asphyxia were reported when the IDF used tear gas to disrupt a demonstration held by Palestinians from Kharbatha Al Misbah village on Highway 443 northwest of Jerusalem. The demonstration was in protest against Barrier construction and discrimination against Palestinians regarding the use of Highway 443. One Palestinian activist was arrested (Ramallah).
- **25 April:** Palestinians threw stones at an Israeli vehicle travelling south of Ramallah. No injuries or damage were reported (Ramallah).
- 27 March: Palestinians threw stones at an Israeli bus travelling near Silwad village. No injuries were reported but the bus sustained some damage (Ramallah).
- 27 April: At the At Tayba partial checkpoint, the IDF requested Palestinian commuters to step out of their cars for inspection. During the inspection, IDF soldiers pointed their guns at and verbally assaulted the commuters. The IDF reportedly smashed the windows of some cars with their guns (Ramallah).
- **28 March:** Palestinians threw stones at an Israeli vehicle travelling near Hizma village No injuries were reported but the vehicle sustained some damage (Jerusalem).
- **28 April:** Two molotov cocktails were thrown at Israeli vehicles travelling near Rantis village. No injuries or damage were reported (Ramallah).

# 2. Physical Protection – other incidents involving casualties<sup>2</sup>

#### Gaza Strip:

- 23 April: A 21-year-old Palestinian shepherd was injured when a landmine exploded while he was accompanying his flock of sheep in the fields east of Jabaliya (North Gaza).
- 24 April: Unknown gunmen abducted a 31-year-old former PA security officer from his home in An Nuseirat Camp. He was physically assaulted and taken to Al Aqsa hospital. The Hamas police arrested the man from the hospital. The motive behind the incident is unknown (Central Gaza).
- 26 April: Four Palestinians were injured during an armed family dispute in An Nuseirat Camp. The police arrived and brought situation under control after arresting several people (Central Gaza).

#### Other incidents (not involving casualties):

- 23 April: Approximately 50 school students demonstrated in front of UNSCO compound to protest against the blockade imposed on Gaza. The protestors handed over a letter addressed to the UN Secretary General (Gaza).
- 23 April: The Palestinian Scholar Association (PSA) installed a symbolic cemetery inside
  Rafah crossing for the 136 people who died because they were unable to leave the Gaza
  Strip for medical treatment. Hamas PLC members participated in the event (Gaza).
- 24 April: Approximately 50 farmers demonstrated at the junction leading to Nahal Oz crossing east of Shuia'iya to protest against the lack of fuel and the closure of the crossings. The protesters did not allow a fuel truck sent to collect diesel for the UN to enter the crossing area, arguing that their needs are more urgent (Gaza).
- 27 April: Approximately 50 Palestinian farmers demonstrated at the junction leading to Nahal Oz crossing east of Shuja'yeh to protest against the closure imposed on Gaza and the shortage of fuel (Gaza).

Also reported in this section are casualties indirectly related to the conflict such as incidents involving Unexploded Ordnance (UXO), traffic accidents between Israeli and Palestinians in the oPt and deaths resulting from delay in receiving medical treatment at a checkpoint or during a military operation/curfew. These casualties are not recorded in the total in Section 1.

- 27 April: Approximately 100 women and their children demonstrated in front of the main gate of UNRWA Field Office to protest against the blockade imposed on Gaza. The protesters handed over a letter addressed to the UN Secretary General (Gaza).
- 27 April: The Army of Islam carried out military training exercises east of Fata Hospital southwest of Sabra. Police reinforcements rushed to the area and brought the situation under control (Gaza).
- 28 April: Representatives of Islamic Jihad, PFLP, DFLP and PRC crossed to Egypt through Rafah crossing to meet with Omar Suleiman, Chief of Egyptian Intelligence Services, to discuss the proposed truce (Rafah).
- 29 April: Approximately 150 members of the Islamic Bloc of Agricultural Engineers and Agricultural Associations organised a demonstration to protest against the blockade imposed on Gaza. The demonstration began at the Unknown Soldier Park and proceeded to the UNSCO offices, where the protestors handed over a letter addressed to the UN Secretary General (Gaza).
- **29 April:** Egyptian Security Forces discovered and destroyed five tunnels along the Egypt-Rafah border (Rafah).

#### West Bank:

Other incidents (not involving casualties/damage):

- 23-26 April: UNRWA closed down its offices in refugee camps in Hebron and Bethlehem governorates (except for schools and clinics) after the Camp Committees rejected its offer to distribute aid to refugees on the basis of one food parcel for families with 1-3 members and two food parcels for those with four or more members.
- 25 April: Six settlers from the settlement of Ma'on, located south of the town of Yatta, threw stones at Palestinian shepherds from the hamlet of Tuba while they were watering their flocks. The shepherds subsequently left the area (Hebron).
- **26 April:** Four Israeli settlers from the settlement of Ma'on, located south of the town of Yatta, threw stones at Palestinian shepherds grazing their lands in the vicinity of Tuba hamlet. The shepherds left the area shortly thereafter (Hebron).

#### Inter-factional violence

#### Gaza Strip:

No incidents to report.

#### West Bank:

Other Incidents (not involving casualties/damage):

 28 April: Three Palestinian prisoners (two political prisoners and one criminal) held at the PA prison in Jericho escaped from prison. In response, the IDF imposed tight restrictions on movement at the checkpoints leading out of Jericho. The PA later caught two prisoners in Ramallah and one in Bethlehem.

# 3. **Shelter and Property**

- 23 April: Israeli settlers from Qarne Shomron settlement threw stones at Palestinian vehicles traveling on Road 55, damaging the wind shield of one taxi (Qalqiliya).
- 23 April: An IAF aircraft fired one missile towards a vehicle carrying Hamas members travelling in Al Amal Quarter in Khan Younis. The missile missed the target and hit a Palestinian house. The house was damaged but no injuries were reported (Khan Younis).

- 24 April: Israeli settlers entered the evacuated Khomesh settlement, attacked a
  Palestinian shepherd from Burqa village, killed two of his sheep and stole another two
  (Nablus).
- 24 April: During the IDF incursion into northeast of Beit Hanun, several greenhouses were destroyed and five houses were damaged (North Gaza).
- 27 April: Four IDF tanks and two bulldozers entered Gaza east of Deir El Balah to
  provide support to an IDF unit operating in the area. The IDF unit occupied four
  Palestinian houses in the area and took sniper position atop their roofs. Six inhabited
  houses were also demolished and 200 dunums of olive trees were uprooted. The IDF
  troops withdrew at 2315 hours (Central Gaza).
- 28 April: During IDF military operation northwest of Beit Hanun an electricity transformer
  was hit by a tank shell, causing a power outage in the northern area. At 2130 hours the
  IDF pulled back to the former industrial zone and the former Nissanit settlement (North
  Gaza).
- 29 April: Israeli settlers from the settlement of Kiryat Arba damaged 11 cars in Jabal Johar area in the H2 area of Hebron City. The attack took place after Kiryat Arba settlers sent out an e-mail declaring the imminent destruction by the IDF of an outpost between the settlements of Kiryat Arba and Giv'at Avot. The removal of the outpost was not carried out (Hebron).

### Other incidents (not involving demolitions/property damage):

- 23 April: The IDF distributed seven orders for the demolition of six houses and a water cistern and three stop building orders against two houses and an animal pen belonging to Palestinians in Duma village. All these orders were issued due to the lack of building permit (Nablus).
- 26 April: The IDF forcibly entered into the sewing workshop at the basement of the Girl's Orphanage (affiliated with the Islamic Charitable Society) in the H1 area of Hebron City and informed the employees that they have one more day before the IDF closes the workshop down and confiscates its contents. The IDF reiterated its decision to close the workshop for a period of three years and subject anyone present in the premises after their closure to a five-year prison sentence. As of 6 May, no execution of the order was carried out.

#### **Natural Resources**

#### **Nablus Governorate:**

Ongoing incidents:

 14 April 2008 to date: Israeli army bulldozers continue to level land north of Huwwara checkpoint.

### Jenin, Tubas, Tulkarm, Qalqiliya and Salfit Governorates:

No incidents to report.

### Ramallah / Al Bireh Governorate:

Ongoing incidents:

- Barrier construction:
  - As of 6 November: Barrier construction has stopped in the Ramallah governorate, including construction on 'Abud land to encircle Beit Arye and Ofarim settlements—as part of the extension of the "Ariel finger." According to the DCL officer in Ramallah, the decision was made due to technical reasons at the Ministry of Defence.
  - Barrier construction on Palestinian land extending between Rantis (northwest of Ramallah governorate) and Beit Nuba (southwest of Ramallah governorate) is complete, except for Al Midya-Ni'lin section.
  - Barrier construction between Al Midya and Ni'lin has stopped pending a
    decision by the Israeli High Court of Justice based on appeals submitted
    by Ni'lin village residents and Hashmona'im settlers (each side is
    demanding that the barrier be pushed closer to the other side).
- Construction of four "fabric of life" roads, which is part of a Gol plan to build roads for Palestinians as an alternative to main roads now inaccessible due to road

obstacles, the route of the Barrier, and the route of roads which Palestinians are restricted from using:

- Construction of a new road between Rantis and Shuqba, parallel to Roads 465 and 446, has almost been completed, except for the final 50 meter section to connect it back to Road 465. The road is open for access between Shuqba and 465 via an underpass at the intersection of 446 and 465.
- Construction of a road between Beit Liqiya and Beit 'Anan has been completed and is now operational.
- Construction continues of a road between Beit 'Ur al Fauqa and Tira via an underpass under Road 443. The Israeli DCL reports that the underpass will be completed during the summer of 2008.
- Construction has begun on a new road between Beit 'Ur al Fauqa and Beituniya. A total of 588 dunums of land were requisitioned and some land levelling at Beit 'Ur al Fauqa has begun. The Israeli DCL reports that the construction of the road will take approximately ten months.

#### Jericho Governorate:

No incidents to report.

#### Jerusalem Governorate:

Ongoing incidents:

- Construction of a "fabric of life" sunken road and a tunnel for use by Palestinians travelling between Al Jib and Biddu villages is complete. The sunken road is located under Road 436 which connects the settlements of Ramot Allon and Givat Ze'ev and is primarily for Israeli use and use by Palestinians from An Nabi Samwil village to access Beit Iksa via Ramot checkpoint. The "fabric of life" road replaces the dirt track between Beit Hanina al Balad and Beit Iksa through Ramot checkpoint, which was closed with cement blocks by the IDF when the sunken road was opened.
- Barrier construction:
  - Construction continues along the projected route in the Jerusalem governorate. Exceptions to this are northeast of Al 'Eizariya towards Ma'ale Adummim settlement. Construction has been stopped along a 3km stretch of the Barrier south of Ma'ale Adummim and Kedar since 3 March 2006 pending an appeal filed by a few Bedouin families who would be displaced if construction continues.
  - The Barrier between the neighbourhoods of Ar Ram and Dahiyat Al Bareed remains incomplete. One detour route for pedestrian and vehicular traffic continues to connect these two neighbourhoods, but when the Barrier is completed, the Dahiyat Al Bareed neighbourhood will be separated from Ar Ram and the rest of the West Bank.
  - The construction of a road barrier continues on Road 1 east of Az Za'ayyem.
  - Since 26 November 2007, Barrier construction has been halted between
     Al Jib and An Nabi Samwil villages due to budget constraints.
- Construction of an Israeli police station (two large buildings) in E1 is mostly complete. E1, or East 1, is an area north of Ma'ale Adummim and Road 1.
   Construction of a road leading to the police station was completed and the road is currently being widened.
- A new "fabric of life" road between Anata and Az Za'ayyem (Road 70) is in the final construction stage to allow Palestinians to enter and exit Az Za'ayyem without using the entrance lane off Road 1 near Zayem checkpoint.
- Construction of a "fabric of life" road around Ma'ale Adummim settlement bloc has not begun. The road is planned to connect the southern and central West Bank such that Palestinians will no longer need to travel on Road 1 through the Ma'ale Adummim settlement bloc. A military order number T/19/07 had been issued to confiscate 1,128 dunums to construct this road.

#### **Bethlehem Governorate:**

Ongoing incidents:

- Barrier construction:
  - Construction of the patrol road along the eastern side of Road 60 to the south of the Tunnel checkpoint continues.

- The Barrier contractor halted the installation of 8-meters-high concrete blocks along Road 60 between Al Khadr Tunnel and Al Nashash (southern entrance of Bethlehem City).
- The Barrier contractor suspended land levelling and asphalting the section of the Barrier to the east of Efrat Settlement.
- Land levelling and installation of 12-meters-high concrete blocks was suspended in the Barrier section between the two tunnels.
- Land levelling for the construction of the Barrier was suspended around the Israeli settlement of Har Gilo.
- Land levelling for the construction of Al Khadr Tunnel was suspended during the reporting period. This tunnel will be the only access point for the Palestinian towns within the proposed Gush Ezion enclave.
- Construction of buildings for new crossing continued next to Al Jab'a checkpoint.
- Land leveling and installation of new buildings at An Nu'man crossing is ongoing.
- Land leveling and construction of new buildings is taking place in Betar Ilit, El'azar, Allon Shevut and Efrat settlements.

#### **Hebron Governorate:**

Ongoing incidents:

- Construction of a building continued next to Beit Yatir checkpoint.
- Pavement of roads and construction of new buildings continued west of Tarqumiya checkpoint.
- Construction of new buildings continued in Karmel, Susyia, Kiryat Arba' and Shani settlements.
- Land leveling for building a new road parallel to Road 60 between Shim'a settlement and Metar checkpoint – is ongoing.

#### Gaza Strip:

- 23 April: An IDF bulldozer accompanied by two tanks entered approximately 80 meters into Gaza south of Sufa crossing under the cover of gunfire. The IDF bulldozers conducted a levelling and excavation operation (Khan Younis).
- 24 April: During the IDF incursion northeast of Beit Hanun, IDF bulldozers conducted a levelling and excavation operation, uprooted 60 dunums of olive trees, destroyed several greenhouses and damaged five houses (North Gaza).
- 24 April: Seven IDF tanks, four APCs and two bulldozers entered 800 meters east of Abassan area east of Khan Younis. IDF bulldozers levelled and excavated agricultural land and uprooted 30 dunums of olive and citrus trees. At 1030 hours the IDF withdrew to the border (Khan Younis).
- 26 April: Three IDF tanks and two bulldozers entered one kilometre into Al Shouka area east of Rafah. The bulldozers conducted a levelling and excavation operation and subsequently withdrew to Kerem Shalom military base (Rafah).
- 27 April: During the IDF ground operation east of Deir El Balah, the IDF uprooted 200 dunums of olive trees and withdrew later in the day (Central Gaza).

# 5. Access and Movement for Civilians

### a) Incidents of curfews

- 23 24 April: The IDF imposed curfew on 'Azzun village from 2100 on 23 April to 1500 on 24 April after stones were thrown at Israeli vehicles travelling on Road 55 from/to Israeli settlements (Qalqiliva).
- **27 28 April:** The IDF imposed curfew on 'Azzun village from 2100 on 27 April to 1500 on 28 April after stones were thrown at Israeli vehicles travelling on Road 55 from/to Israeli settlements (Qalqiliya).
- **29 April:** The IDF imposed curfew on 'Azzun village at 1700 hours after stones were thrown at Israeli vehicles travelling on Road 55 from/to Israeli settlements (Qalqiliya). Ongoing incidents:
  - 17 May to date: Palestinians living in Gaza Strip areas (northeast of Beit Hanun and north, and northwest of Beit Lahiya) continue to maintain a self-imposed curfew after dark due to IDF military operations.

#### b) Access to education

**24 and 28 April:** All schools were closed in 'Azzun village due to the curfew imposed on the village (Qalqiliya).

Ongoing incidents:

- 12 April to date: Attendance at some schools and universities in the Gaza Strip was disrupted due to the fuel shortage.
- The IDF and Israeli Police escorting Palestinian students to and from their elementary school in At Tuwani—the escort has been provided since 2004 to protect students from attacks by Israeli settlers from the Ma'on settlement—continue to leave school children half-way through. The children thus have to walk the remaining distance alone, including passing immediately near the outpost of Havat Ma'on. Moreover, while the IDF escort includes soldiers walking beside the children, the soldiers usually stay in the IDF jeep while the students walk in front of the jeep (Hebron).

#### c) Access to employment

23 - 27 April: All Palestinian workers and traders holding work permits were denied access to Israel and East Jerusalem due to the Jewish Passover holiday and the resultant closure imposed on the West Bank.

Ongoing incidents:

 12 March 2006 to date: Palestinian workers from the Gaza Strip have been prevented from entering Israel.

#### d) Closures/movement restrictions

#### **Nablus Governorate:**

27 April: The IDF closed Beit Iba checkpoint for 80 minutes to inspect a suspicious object.

**28 April:** The IDF opened the two metal gates at both sides of 'Asira ash Shamaliya checkpoint and allowed free access between Nablus City and the northern villages. However, the checkpoint's structure remains in place and random checks by the IDF were reported.

Ongoing incidents:

- 29 October 2007 to date: The IDF continues to close the southern entrance of Jamma'in village with road blocks. The closure was placed four days after a drive-by shooting incident on an adjacent road (Road 505).
- 28 March 2007 to date: The IDF continues to close Shave Shomron checkpoint for all Palestinians, ambulances, UN and international organisations (Nablus).

#### Jenin Governorate:

Ongoing incidents:

- 30 August 2006 to date: The IDF prohibits the free movement of all commercial trucks to the Barta'a enclave surrounded by the Barrier. Forty trucks, registered with the IDF at the checkpoint with a freight load of under two tonnes are allowed to transport food products. Other materials require prior coordination.

#### **Tubas Governorate:**

No incidents to report.

#### **Tulkarm Governorate:**

Ongoing incidents:

- 15 February 2008 to date: The IDF continues to close the road connecting Shuweika to Iktaba village with an earth mound.
- 8 February 2008 to date: The IDF continues to close four roads connecting Bal'a with Road 57, 'Anabta, Deir al Ghusun and Iktaba with earth mounds.
- 12 December 2007 to date: The IDF continues to close the road connecting Dhinnaba to Kafr al Labbad with an earth mound.

#### Qalqiliya Governorate:

**23 April:** The IDF closed the road between 'Azzun and 'Asla villages with an earth mound. On 25 April, Palestinians opened the earth mound.

25 April: The IDF closed the main entrance of Jinsafut village with an earth mound.

**25 April:** The IDF closed the DCO checkpoint at the eastern entrance of Qalqiliya City for three hours as they were holding a military training thereat. Ongoing incidents:

- 4 March to date: The IDF continues to close the road connecting Izbat at Tabib with 'Azzun village with an earth mound.
- 2 March to date The IDF continues to close the dirt roads connecting Hajja with Al Funduq and Hajja with Baqat al Hatab.
- 9 February 2008 to date: The IDF continues to close the northern entrance of 'Azzun with concrete blocks and an earth mound. The IDF also continues to close with an earth mound a dirt road connecting 'Azzun with Kafr Laqif, after stones were thrown at Israeli vehicles travelling on Road 55 en route to Israeli settlements.
- 13 July 2007 to date: IDF soldiers positioned at the checkpoint placed at the eastern entrance of Qalqiliya City (DCO) continue to prevent Palestinians with Israeli citizenship from entering Qalqiliya City with vehicles.

#### Salfit Governorate:

Ongoing incidents:

- 27 November 2007 to date: The IDF continues to close the entrance of Kifl Haris with road blocks.
- The IDF continues to close the gate at the northern entrance of Kafr ad Dik.

#### Ramallah / Al Bireh Governorate:

Ongoing incidents:

 1 July 2007 to date The road gate of At Tira (Ramallah) opens three times a day for half an hour each time. The gate is used by the residents travelling in Palestinianplated taxis to enter/exit the village—only 11 Palestinian taxis are permitted to cross and travel on Road 443.

### Jericho Governorate/Jordan Valley:

Ongoing incidents:

- 2 January 2008 to date: The Dead Sea checkpoint functions as a partial checkpoint. Palestinians with West Bank IDs and Palestinian-plated vehicles are no longer prohibited from accessing the Dead Sea area when the checkpoint is not staffed. When the checkpoint is staffed, however, the Israeli Border Police denies passage to all Palestinians and their vehicles. The checkpoint is staffed on weekends, Jewish holidays, and randomly during the week.
- 26 September 2007 to date: All West Bank ID-holders can enter Jericho via the DCO and Yitav checkpoints. For exiting Jericho city, only Palestinians from the northern West Bank (Nablus, Qalqiliya, Jenin, Tulkarm) are not allowed to use the DCO checkpoint and are forced to use Yitav checkpoint north of Jericho City.
- 26 April 2007 to date: Movement of Palestinians who are not Jordan Valley residents into areas north of Yitav checkpoint continues to be controlled through four checkpoints: Tayasir, Hamra, Ma'ale Efraim and Yitav. West Bank private vehicles continue to be prohibited from entering the Jordan Valley north of Yitav checkpoint but non-Jordan Valley residents no longer require a permit to enter the Jordan Valley using public transportation through Hamra and Tayasir checkpoints. All Palestinians have access to Jericho City with their personal vehicles.

#### Jerusalem Governorate:

**26 April:** The Israeli Police and the IDF denied thousands of Christian worshipers access to the Old City in Jerusalem and to the Church of the Holy Sepulchre to celebrate the Christian Holy Fire day. Many worshipers, including women and elderly, were verbally insulted by the Israeli Police and IDF.

Ongoing incidents:

- 25 March 2008 to date: The road between Beit Hanina al Balad and Ramot checkpoint is closed. Travel for all Palestinians between the Bir Nabala and Biddu areas is via the new sunken road/tunnel between Al Jib and Biddu. Ramot checkpoint continues to operate only for Jerusalem ID holders and residents of An Nebi Samwil, which is located within the seam zone near Har Smuel settlement, and provides access in the direction of Beit Iksa only.

#### **Bethlehem Governorate:**

**22-28 April:** Palestinians (workers and otherwise) holding valid permits were prevented from reaching East Jerusalem and Israel due to the general closure imposed on the West Bank. Humanitarian cases and employees at international organizations were allowed to cross.

#### **Hebron Governorate:**

**22-28 April:** Palestinians (workers and otherwise) holding valid permits were prevented from reaching East Jerusalem and Israel due to the general closure imposed on the West Bank. Humanitarian cases and employees at international organizations were allowed to cross.

Ongoing incidents:

 2 April to date: The IDF continues to reinforce the closures beyond the Beit Yatir checkpoint by placing cement blocks on agricultural roads connecting Palestinian villages to areas inside Israel.

### Gaza Strip

Functioning of Gaza crossing points:

- Erez was open on four days this week for the movement of diplomats, international humanitarian workers and critical medical cases with special coordination arrangements. National UN staff members continue to be denied entry to Israel, even with permits and prior co-ordination. Senior Palestinian businessmen were also allowed to cross this week. (Appendix for daily log of movement is based on information provided by the Palestinian civil affairs office due to the absence of Palestinian DCL staff at the present time).
- **Rafah** crossing continues to be closed. It was last open on 9 June but it was operated since then on a few occasions on an exceptional basis.
- Karni crossing: the conveyor belt/chute was open on one day this week to transfer wheat grain and animal feed into Gaza. Since 12 June, however, the crossing has remained closed for other imports and all exports.
- Sufa crossing was open on five days this week; it was closed on 25 and 26 April.
   After being closed between 28 October and 22 December, Sufa crossing was reopened on 23 December for humanitarian and commercial commodities. Sufa has been the principal alternative commercial crossing following the closure of Karni crossing in mid-June.
- Kerem Shalom crossing was closed this week for the entry of commercial and humanitarian goods. During the closure of Sufa between 28 October and 22 December, Kerem Shalom was effectively the only crossing allowing the entry of commercial and humanitarian goods into Gaza.
- Nahal Oz energy pipelines were open on three scheduled operating days this week.
- Gaza fishermen continue to be permitted to fish up to six nautical miles off the coastline.

#### Ongoing incidents:

- Following Israel's unilateral disengagement from the Gaza Strip in September 2005, the IDF announced that Palestinians should keep a distance of at least 150 metres from the perimeter fence along the eastern and northern borders of the Gaza Strip.
- On 28 December 2005, the IDF declared the former northern settlement bloc to be a "no-go" zone. Entry into the area for the 250 Palestinian residents and international organisations requires prior coordination with the IDF. Since 17 May, IDF presence in this area has been enforcing this ban.
- 17 May to date: Palestinian farmers have been unable to reach their farms in the areas east and north of Beit Hanun and north and northwest of Beit Lahiya due to ongoing IDF military activities. Palestinian farmers have also been unable to reach farms located east of Al Bureij Camp and east of Khan Younis due to intermittent military operations by the IDF.

#### **Method and Sources**

The information used to compile these Briefing Notes comes from a range of sources with a field presence in the West Bank and the Gaza Strip. The accuracy of the reported information is ensured through the corroboration of reports by two additional sources. Typically, the OCHA Field Coordination Unit (FCU) receives an initial incident report from a source, which is verified through visits to the incident site in addition to further corroboration with a third source, such as an NGO. In addition, OCHA FCU collects military orders as documentary evidence and provides information on incidents witnessed in person.

In the interests of timeliness and readability, the sources are not listed for each incident within the texts of the report. Listed below are the sources relied upon each week in compiling this Briefing:
